Dear young people,

The Balloon Sport Youth of the German Balloon Association (Ballonsportjugend Deutscher Freiballonsport-Verband e.V.) is happy to invite you to the 13th International Youth Camp 2013!

We welcome all young people who want to fly in a balloon and make the experience of a summer tent ballooning youth camp in Germany. Among other things, our programme will consist of the following activities:

- ballooning & chasing the balloon
- introduction to the safety of ballooning
- explore the surrounding area
- campfire romanticism - event education games
- swimming - football – volleyball
- model ballooning
- and a lot more !

It is important for us to make our sport accessible to young people and to achieve a good team spirit. Unfortunately, balloon flying is only possible at good weather in early morning or late evening, so all our activities depend very much on the current weather conditions. We will often decide situational what is feasible with the group. Our accommodation will be at the site of the SC Bruckberg near Landshut, where we will spend the nights in our tents. Each of our tents takes hold of 8 participants. The meals will be cooked by all participants with the help of our kitchen team on site.

## Camp rules of the Balloon Sport youth (valid for all Camps of the BSY)

To make the youth camp work and bring fun to all the participants as well as the camp leaders, drivers and cooks, every participant has to keep to some rules, which are listed below.

1. When building up or taking down the camp, every participant has to help, as well as at preparations for activities during the camp.
2. Every participant has to take care of his personal belongings by him- or herself. The camp leaders are not responsible for looking after lost things of participants.
3. As we camp in nature, please think of our environment and avoid unnecessary waste. The waste we produce nevertheless has to be disposed to the provided bins.
4. Sleeping time is announced at the black board as necessary and has to be kept.
5. The consumption of alcohol is subject to relevant law. At obvious disregard, the camp leaders reserve the right to remove the participant from the camp.
6. In all buildings, tents, cars, balloons and near the balloons, smoking is strictly prohibited. (Consequences have to be expected).
7. Swimming is only allowed with permission of the camp leaders.
8. The participants' cellphones have to be switched quiet at night.

As a participant, I am prepared to support the camp, not behave unpleasant and am hereby aware that, in case of heavy misconduct during the camp, I can be sent home at own expenses. I have read the camp rules thoroughly and I am prepared to keep to these rules during the camp.
